he burden of hospital audits by both government contractors and commercial health plans continues unabated. There is still confusion over interpretation and implementation of the "two midnight rule". States are ramping up their own Medicaid RAC contractors, and especially during the past year Medicare Advantage plans and commercial insurers are adopting aggressive auditing tactics to compound the burden on hospitals. Hospitals' rightful appeals of this growing body of denials in turn have completely overwhelmed an understaffed collection of Administrative Law Judges, and hearings are taking two years when they are even able to be scheduled. Members of Congress have heard hospital complaints loud and clear and demanded reform, MedPAC has even weighed in, and there may be a glimmer of hope in the courts with the new administration adding additional unknowns.

But never has it been more important for hospital to 'get it right the first time' when it comes to proper documentation of inpatient care and proper decision making regarding whether a patient meets the criteria for an inpatient admission or should be placed into observation status or treated in an outpatient setting. 
