

### An Example of a Corporate RAC Certificate Program:



ne of the most significant changes in the Medicare program recently has been the introduction of "recovery audit contracting" (RAC) as a way of assuring that proper payments are being made for Medicare services. In the new RAC model, contractors are incentivized with contingency fees to find and recoup improper overpayments to providers of Medicare services. (Providers of course benefit from the identification of underpayments as well, but these represent a very small part of the action.)

Based on the success of the RAC demonstrations authorized by Section 306 of the Medicare Modernization Act of 2003, the RAC process is now back on track for permanent and nationwide implementation, as required by Section 32 of the Tax Relief and Health Care Act of 2006. On October 1, 2008 CMS announced the four contractors who will manage the permanent program in four respective geographic regions; and on February 4, 2009 CMS announced that the parties involved in the protest of those contractor awards had reached a settlement and that national implementation would resume.

CMS has made a number of changes based on lessons learned in the demonstration regarding RAC contractor staff expertise, limits on records, customer service and transparency requirements, and oversight. These changes, and new issues, will be discussed in the context of hospitals' experience, lessons learned, and advice as the national RAC program unfolds. The results of the GAO study of RAC implementation, previewed at the first Medicare RAC Summit, will also be presented.

But there is a larger program integrity agenda in play, and the Summit will also zero in on the most important components of that agenda for hospitals as well. Individual sessions will highlight the role and responsibility of the MACs, the audit MICs, and the ZPICS, and attendees will hear from the HHS Office of the Inspector General on its plans for FY 2010 and beyond.

The Summit offers a preconference RAC "Boot Camp" for those newer to the program or wishing to refresh their knowledge, as well as a Medicare RAC Certificate Program for those who want to take a deeper dive into the subject matter. Finally, the Summit continues to break new ground by permitting registrants to enjoy the complete Summit experience online through both realtime and archived access to all Summit presentations.

### THE MEDICARE RAC CERTIFICATE PROGRAM

### **Overview**

The National Medicare RAC Summit is offering a Medicare RAC Certificate Program in the form of an optional course within the conference for attendees wishing to take a deeper dive into the Summit's subject matter.

### The Medicare RAC Certificate Program curriculum and requirements are as follows:

- Complete preconference readings (6 hours).
- Complete online training modules on preparing for and responding to RAC audits, prepared by Davis Wright Tremaine and Deloitte & Touche (3 hours).

### Who Should Attend?

Those who are interested in understanding and working successfully in the new Medicare RAC environment. This may include government agencies, consumer groups, patient quality organizations, health plans, hospitals, nursing homes, physicians and physician organizations, home health agencies, other providers of Medicare services (ambulance, DME, lab), nurses and other clinicians, medical coding and billing staff, health care financial and auditing personnel, and many others.

### **Learning Objectives**

The purpose of the Medicare RAC Certificate Program is to give participants the understanding and tools necessary to work successfully with the new Medicare RAC process, requirements, and timetable. Program participants will learn the origins and purpose of the RAC approach, the results and lessons learned from the RAC demonstrations, the basic building blocks of the RAC process, and the current issues surrounding national implementation of RAC. By the end of this training, participants will be able to create an action plan that will outline key initiatives to be taken with respect to Medicare RAC implementation in their own organizations.

### **Program Description**

This is a practical, in-depth program for professionals who want to understand Medicare RAC issues in the context of their own local setting. The program will be geared to those who have limited training, but will also cater to those who have increasing levels of knowledge and training in the field. At the end of the program, participants will have 90 days to complete the online examination. Completion of the five elements of the training will earn the participants a certificate of completion.

### **Program Completion**

Those who successfully complete the program requirements (see the five bulleted requirements above), including preconference readings and an online post conference test with a score of seventy percent (70%) or more, will receive a certificate of completion of the Medicare RAC Certificate Program.

### **Frequently Asked Questions**

### Is the Medicare RAC Certificate Program a professional certification program?

It is not. The program constitutes an attempt to organize a focused curriculum around implementation strategies and issues pertaining to Medicare RAC, while giving evidence of successful completion of that body of knowledge through the issuance of a certificate of completion.

Please describe the post meeting online examination. The post-meeting online examination is a multi-question examination based upon the information made available in the preconference readings, online courses, preconference Boot Camp, and the Summit itself. You may take this examination at any time during the ninety (90) days following the Summit. You will be given a web link to the examinations and a unique username and password to access the examination. You will have one hour to complete the examination once you have commenced it. You may take the examination up to three times. Please note that new questions will rotate through the examination. You must score seventy percent (70%) or more to successfully complete this requirement.

Has any other conference offered a comparable certificate program? Yes, the Quality Colloquium at Harvard University, www.QualityColloquium.com, has offered a Patient Safety Certificate Program, www.qualitycolloquium.com/certificate.html, for the past two years. Similar training programs have been offered in 2009 in connection with the National Medical Home Summit, the National Disclosure Summit, and the National Medicare Readmissions Summit.



### THE FOLLOWING REGISTRATION TERMS AND CONDITIONS APPLY

### **REGARDING ONLINE REGISTRANTS**
